## Method

### Pressure Washer

Choose the appropriate dilution from the list above spray on with low pressure spray and rinse with hot or cold high pressure water.

**Foam.** Apply appropriate dilution using a foam box or foaming lance. Rinse with hot or cold high pressure water.

**Manual.** Spray swab or brush onto the surface to be cleaned and agitate to loosen the soil. Wipe up dirty solution with cloth or mop or use a wet-pick-up vacuum. Rinse well with clean water.

**Machine** When using a scrubbing machine or scrubber dryer, add the product to the solution tank and fill with water in the correct proportion and use following the manufacturer's instructions.
